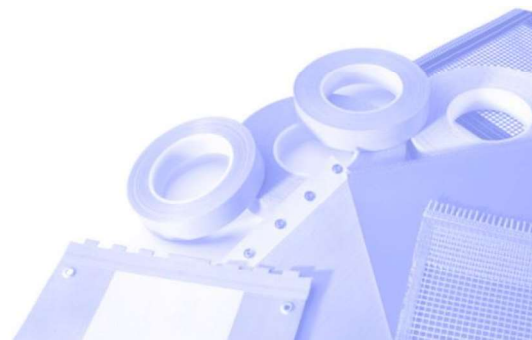
REACH and RoHS Regulation continued.

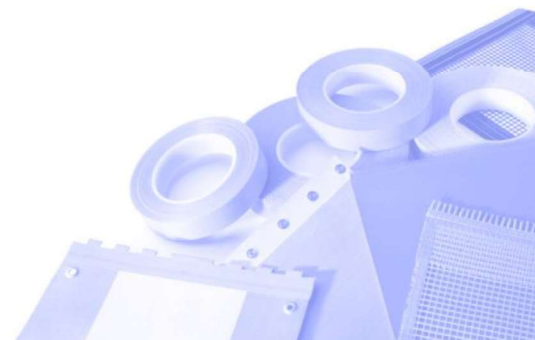


